*All records including video recordings, all "Briefing" staff notes, staff members involved in this legislation process, documents and related documentation for viewing access on the City of Atlanta City Council Resolution 14-R-3974 to include the entire file as to employee records who worked on the preparation, drafting and production to be used as presentation to the Public Safety Committee on all meetings, any and all Georgia Environmental Protection Division (EPD) (Land and Air) communications considered for legislation, and all Georgia Department of Natural Resources communications considered for legislation, All correspondence with any Court, legal actions, Studies, surveys, Notes, all notifications to the Public Safety Committee during public meetings and in private meetings of the City of Atlanta City Council as to internal administration documents and communications, All documents presented by the Law department used to influence, Public Safety Committee regarding the voting for authorization to use Public funds to acquire land that contains*

*massive quantities of toxic, hazardous waste. properties purchased for said owned landfill. Any Health Studies, Any communications to the Department of health, any and all communications email, phone logs, texts with the Office of Research and Policy Analysis all insurance policies in place to protect the City of Atlanta for such liabilities.*

The City Council is not the custodian of any records related to Human Resources, Georgia Environmental Protection Division or Natural Resource communications. The City Council is also not the custodian of any records related to correspondence with any 'court, legal actions, studies, surveys, or notes. I am in need of more specificity as to 'communications, email, phone logs, or texts to the Office of Research & Policy Analysis to complete that request. Please provided any estimated dates, times, or individuals you may believe are associated with this request and I will conduct a search for that information.
